Description of necessary first aid measures

Eye contact

Precautions for safe handling

Protective measures

Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitisation problems or asthma, allergies or chronic or recurrent respiratory disease should not be employed in any process in which this product is used. Section 8. Exposure controls/personal protection

Appropriate engineering controls
