**Conditions for safe storage, including any incompatibilities** : Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabelled containers. **Appropriate engineering controls** : Good general ventilation should be sufficient to control worker exposure to airborne contaminants.

### Individual protection measures

Appropriate techniques should be used to remove potentially contaminated clothing. Wash contaminated clothing before reusing.
