### **Description of necessary first aid measures**

**Eye contact** 

: Get medical attention immediately. Call a poison center or physician. Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. ### **Small spill**

### **Precautions for safe handling**

### **Protective measures**
