Section 4. First aid measures

Description of necessary first aid measures

Eye contact

In the event of any complaints or symptoms, avoid further exposure. Wash clothing before reuse. Clean shoes thoroughly before reuse.

Ingestion

If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Stop if the exposed person feels sick as vomiting may be dangerous. Section 7. Handling and storage

Precautions for safe handling

Protective measures
