Section 4. First aid measures

Description of necessary first aid measures

- Eye contact** : Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention if irritation occurs.
- Inhalation** : Remove victim to fresh air and keep at rest in a position comfortable for breathing. Section 5. Firefighting measures

Extinguishing media

Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

Do not touch or walk through spilt material. Avoid breathing vapour or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Methods and material for containment and cleaning up

Section 7. Handling and storage

Precautions for safe handling

Avoid release to the environment. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use.
