### Section 4. First aid measures

### **Description of necessary first aid measures**

**Eye contact**

Ingestion

Remove victim to fresh air and keep at rest in a position comfortable for breathing. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Stop if the exposed person feels sick as vomiting may be dangerous. Do not induce vomiting unless directed to do so by medical personnel. ### **Environmental precautions**

#### Methods and materials for containment and cleaning up

### **Small spill**

### Precautions for safe handling

# Appropriate engineering controls
