Skin contact

#### Specific hazards arising from the chemical

Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. ## Appropriate engineering controls

: Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits.
