# Section 4. First aid measures

#### **Description of necessary first aid measures**

**Eye contact** 

: Get medical attention immediately. Call a poison center or physician. Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. ## Large spill

#### Precautions for safe handling

#### **Protective measures**

# Appropriate engineering controls

: Use only with adequate ventilation.
