Description of necessary first aid measures

Eye contact

Special protective actions for fire-fighters

: Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Methods and material for containment and cleaning up

Small spill

Precautions for safe handling

Protective measures
