4.1 Description of first aid measures

Ingestion	: Get medical attention immediately. Call a poison center or physician. Wash out mouth with water. Remove dentures if any. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Stop if the exposed person feels sick as vomiting may be dangerous. Do not induce vomiting unless directed to do so by medical personnel. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. #### 7.1 Precautions for safe handling

Protective measures	: Put on appropriate personal protective equipment (see Section 8). #### 8.2 Exposure controls

Appropriate engineering controls	:	Use only with adequate ventilation. #### Skin protection

#### Hand protection

There is no one glove material or combination of materials that will give unlimited resistance to any individual or combination of chemicals.
