#### Inhalation

# Section 5. Fire-fighting measures

## **Extinguishing media**

Suitable extinguishing media

Specific hazards arising from the chemical

: Flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. #### Personal precautions, protective equipment and emergency procedures

### Methods and materials for containment and cleaning up

**Small spill**

#### **Precautions for safe handling**

#### **Protective measures**

Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. # Appropriate engineering controls

: Use only with adequate ventilation. 
