### Section 5. Firefighting measures

#### Specific hazards arising from the chemical

Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. #### **Environmental precautions**

#### Methods and material for containment and cleaning up

#### **Small spill**

### Section 7. Handling and storage

#### **Precautions for safe handling**

#### **Protective measures**

### Appropriate engineering controls

: Use only with adequate ventilation.
