## Section 5. Firefighting measures

## Section 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

### Methods and material for containment and cleaning up

- Large spill** : Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas.
