### Description of necessary first aid measures

Eye contact

# Section 5. Firefighting measures

Specific hazards arising from the chemical

# Section 7. Handling and storage

Conditions for safe storage, including any incompatibilities

: Store in accordance with local regulations. Store in a segregated and approved area. # Recommended monitoring procedures
