# Section 4. First aid measures

### **Description of necessary first aid measures**

**Eye contact**

Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Chemical burns must be treated promptly by a physician.

Inhalation

If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. ### Ingestion

# Methods and materials for containment and cleaning up

**Small spill**

Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

#### Large spill

Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). # Section 7. Handling and storage

#### Precautions for safe handling

**Protective measures**

# Appropriate engineering controls

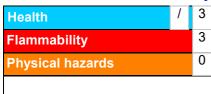
