- Specific hazards arising from the chemical** : In a fire or if heated, a pressure increase will occur and the container may burst.

Personal precautions, protective equipment and emergency procedures

Methods and material for containment and cleaning up

Precautions for safe handling

- Conditions for safe storage, including any incompatibilities** : Store in accordance with local regulations. - Appropriate engineering controls** : Good general ventilation should be sufficient to control worker exposure to airborne contaminants.

Skin protection

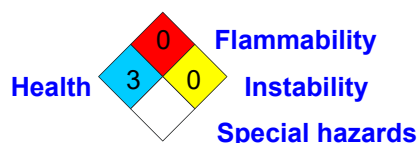
