# Section 4. First aid measures

#### **Description of necessary first aid measures**

### **Eye contact**

: Get medical attention immediately. Call a poison center or physician. Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. ### Precautions for safe handling

# Appropriate engineering controls
