Section 4. First aid measures

Description of necessary first aid measures

Inhalation

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. Section 6. Accidental release measures

Environmental precautions

: Avoid dispersal of spilt material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air). Water polluting material. Methods and material for containment and cleaning up

Small spill

Section 7. Handling and storage

Precautions for safe handling

Section 8. Exposure controls/personal protection

Hygiene measures
