5.3 Advice for firefighters

### 6.3 Methods and material for containment and cleaning up

### 7.1 Precautions for safe handling

Appropriate engineering : controls	Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits.
