### **Description of necessary first aid measures**

### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

### Methods and material for containment and cleaning up

# Section 7. Handling and storage

### Precautions for safe handling

**Protective measures** 

: Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. Do not get in eyes or on skin or clothing. Do not ingest. Avoid breathing vapour or mist. Avoid release to the environment. Use only with adequate ventilation. # Appropriate engineering controls
