Special protective actions for fire-fighters

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Section 7. Handling and storage

Precautions for safe handling

Protective measures

Appropriate engineering controls
