Methods and material for containment and cleaning up

Precautions for safe handling

Avoid release to the environment. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. - Appropriate engineering controls** : Good general ventilation should be sufficient to control worker exposure to airborne contaminants.
