8.2 Exposure controls

Appropriate engineering controls

: Noid breathing dust. Where reasonably practicable, this should be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain exposure to dusts below the OEL, suitable respiratory protection must be worn.

The recommended OEL for coating powders containing TGIC is 3 mg/m³. This OEL must be considered as a maximum exposure limit averaged over the measured time period (the normal time period in a working day is 8 hours), not normally to be exceeded.
