Extinguishing media

Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures : No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Methods and materials for containment and cleaning up

Appropriate engineering controls : Good general ventilation should be sufficient to control worker exposure to airborne contaminants.
