# **SECTION 4: First aid measures**

#### 4.1 Description of first aid measures

**Eye contact**

Inhalation

Never give anything by mouth to an unconscious person. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. #### Large spill

# Appropriate engineering controls
