Section 4. First aid measures

Description of necessary first aid measures

Precautions for safe handling

- Protective measures** : Put on appropriate personal protective equipment (see Section 8). Do not handle until all safety precautions have been read and understood. Do not get in eyes or on skin or clothing. Do not ingest. Avoid release to the environment. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Empty containers retain product residue and can be hazardous.
