#### Inhalatior

If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. #### Large spill

# Appropriate engineering controls

: Use only with adequate ventilation.
