Description of necessary first aid measures

Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

Precautions for safe handling

Protective measures : Put on appropriate personal protective equipment (see Section 8). Do not ingest. Avoid contact with eyes, skin and clothing. Avoid release to the environment.
