Skin contact: Get medical attention immediately. Call a poison center or physician. Wash with

plenty of soap and water. Remove contaminated clothing and shoes. Wash contaminated clothing thoroughly with water before removing it, or wear gloves. Continue to rinse for at least 10 minutes. Protective measures
