Section 4. First aid measures

Description of necessary first aid measures

Section 7. Handling and storage

Precautions for safe handling

Avoid exposure during pregnancy. Do not handle until all safety precautions have been read and understood. Do not get in eyes or on skin or clothing. Do not breathe vapour or mist. Do not ingest. If during normal use the material presents a respiratory hazard, use only with adequate ventilation or wear appropriate respirator.
