#### **B.** Skin contact

#### A. Precautions for safe handling

- **B.** Conditions for safe storage, including any incompatibilities
- Store in accordance with local regulations. Store in a segregated and approved area. Store in original container protected from direct sunlight in a dry, cool and wellventilated area, away from incompatible materials (see Section 10) and food and drink. - B. Appropriate engineering: Use only with adequate ventilation.
