Description of necessary first aid measures

Eye contact

Skin contact

Ingestion

Section 7. Handling and storage

Protective measures

Put on appropriate personal protective equipment (see Section 8). Do not get in eyes or on skin or clothing. Do not breathe vapour or mist. Do not swallow. Avoid release to the environment. Appropriate engineering controls
