Description of necessary first aid measures

Eye contact

: Get medical attention immediately. Call a poison center or physician. Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Methods and material for containment and cleaning up

Small spill

Precautions for safe handling

Protective measures

Appropriate engineering controls
