### Section 4. First aid measures

#### **Description of necessary first aid measures**

#### Inhalation

: Get medical attention immediately. Call a poison center or physician. Remove victim to fresh air and keep at rest in a position comfortable for breathing. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. ### Methods and material for containment and cleaning up

**Small spill**

# Appropriate engineering controls

: Use only with adequate ventilation.
