Description of necessary first aid measures

Eye contact

Section 5. Firefighting measures

Specific hazards arising from the chemical

Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. Methods and material for containment and cleaning up

Small spill

Precautions for safe handling

Protective measures

Advice on general occupational hygiene

Appropriate engineering controls

: Use only with adequate ventilation.
