## Section 3. Composition/information on ingredients

#### **Description of necessary first aid measures**

**Eye contact**

Ingestion

## Section 6. Accidental release measures

#### **Small spill**

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

#### Large spill

## Section 7. Handling and storage

### **Precautions for safe handling**

#### **Protective measures**

Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. # Appropriate engineering
