## Section 4. First aid measures

Inhalation

# Section 5. Fire-fighting measures

Specific hazards arising from the chemical

: Highly flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. This material is very toxic to aquatic life with long lasting effects. #### Methods and materials for containment and cleaning up

**Small spill**

## **Precautions for safe handling**

Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. #### **Hand protection**
