Description of necessary first aid measures

Eye contact

Specific hazards arising from the chemical

: Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. Section 7. Handling and storage

Precautions for safe handling

Protective measures

Appropriate engineering controls
