Inhalation

Ingestion

Section 7. Handling and storage

Precautions for safe handling

: Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Recommended monitoring procedures
