Section 4. First aid measures

Description of necessary first aid measures

Section 5. Firefighting measures

Extinguishing media

Methods and material for containment and cleaning up

Section 7. Handling and storage

Precautions for safe handling

- Protective measures** : Put on appropriate personal protective equipment (see Section 8). Do not ingest. Avoid release to the environment. If during normal use the material presents a respiratory hazard, use only with adequate ventilation or wear appropriate respirator.
