#### Large spill

Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach the release from upwind. #### Precautions for safe handling

#### **Protective measures**

# Appropriate engineering controls

: Use only with adequate ventilation.
