May be blended with Jotun Thinner No. 19 when spraying in cold conditions, or with Jotun Thinner No. 12 when spraying in hot conditions. Can also be used as cleaner for pumps and tools before and after painting.

When thinners are used as a cleaning solvent, the use must be in accordance with prevailing local regulations.
