# **Jotaguard 100**

### **Product description**

This is a two component solvent free polyamine cured epoxy coating. It is a surface tolerant product that can be applied without dew point restrictions, and on damp and wet surfaces. It has good chemical, abrasion and impact resistance. Can be used as primer, mid coat, finish coat or as single coat system in atmospheric and immersed environments. Suitable for properly prepared carbon steel, galvanised steel, stainless steel, aluminium and a range of aged coating surfaces.

#### **Typical use**

Recommended for offshore environments, including splash zones, refineries, power plants, bridges, buildings, mining equipment and general structural steel. Only aluminium containing versions to be used as first coat in immersed environments.

The theoretical volume solids of  $98\% \pm 2$  for Jotaguard 100 is informed as required in Petrobras Standard N-2680 – Surface Tolerant Solvent Free Epoxy Paint for Wet Surfaces. The purposes for calculation of theoretical spreading rate and wet film thickness to be applied, a practical value of  $90\% \pm 2$  (according to ISO 3233) shall be considered.

The resin system is subject to some shrinkage during the curing process. This results in lower dry film thickness and practical spreading rate lower than the theoretically calculated.

# **Surface preparation**

Optimum performance, including adhesion, corrosion protection, heat resistance and chemical resistance is achieved with recommended surface preparation.

to achieve the specified dry film thickness.
