This is a two component solvent free amine cured phenolic/novolac epoxy coating reinforced with ceramic fillers and glass flakes. It has a high resistance to most sour crude oils and a wide range of chemicals and solvents. Can be used as primer, mid coat or finish coat in atmospheric and immersed environments. Suitable for properly prepared carbon steel substrates.

Dried/cured for service: Minimum time before the coating can be permanently exposed to the intended environment/medium.
