This is a mineral micro bead, to be mixed with the paint before application. The recommended usage is 0.8 kg to 1 kg per 15 liters of paint. Suitable as anti-skid material in a wide range of coating systems in atmospheric environments. Suitable on any type of surface, depending on the specific coating system.

Typical use

Can be used on helidecks, walkways, ramps, weigh bridge decks, decks in general where non-slip properties are required.
