Specially designed for new construction where short dry to handle and over coating times are required. Suitable for properly prepared aluminium, carbon steel, galvanised steel, shop primed steel and stainless steel substrate.

This product is tintable in a wide range of colours in Jotun's Multicolor Industry (MCI) system.
