Typical use

Specially designed for speeding up curing of polyurethane products. Recommended usage is max. 5% on mixed product.

Note that the pot life will be reduced.

Excessive addition may cause reduction of levelling, gloss and adhesion to substrate.

When thinners are used as a cleaning solvent, the use must be in accordance with prevailing local regulations.
