# **Product description**

This is a one component state of the art chemically hydrolysing silyl methacrylate antifouling coating. It provides excellent fouling protection, ultra low friction and incomparable hull performance. This is achieved through highly predictable and stable self polishing characteristics reducing hull deterioration, friction and speed loss. The initial smooth surface provides a very good out of dock performance. To be used as finish coat in immersed environments only. It can be applied at sub zero surface temperatures.

Designed as a premium solution for vessels trading at a high speed and medium to high activity, where the main focus is long term hull performance and fuel saving. Dry to over coat, minimum: The recommended shortest time before the next coat can be applied.

Dried/cured for immersion: Minimum time before the coating can be permanently immersed in sea water.
