This is a two component solvent free, LEED compliant aromatic Polyurethane coating. It an elastomeric coating with superior abrasion, impact, chemical and slip resistance. It can be used an intermediate coat for UV exposed areas , and as a Topcoat for non-exposed areas .

Designed for the different levels of the car parks exposed to medium and heavy traffic, mechanical and chemical exposure. Typically recommended for all car park areas such as: ramps, parking bays, drive ways, pedestrian walkways, roof decks.

Laitance deposits are best removed by Planetary diamond disc grinder or by captive blasting followed by vacuum cleaning to remove dust debris. For old concrete, Jotun technical team should visit the site and appropriate surface preparation methodology should be recommended and that is to be followed.

Application

Application methods

The product can be applied by

Roller: Use medium/small pile roller. Care must be taken to achieve the specified dry film

thickness. Refer to the Application Guide (AG) for additional information.

Conditions during application :

The temperature of the substrate should be minimum 10 $^{\circ}$ C and at least 3 $^{\circ}$ C above the dew point of the air, measured in the vicinity of the substrate. Good ventilation is usually required in confined areas to ensure proper drying. The moisture content in the substrate should not exceed 4 $^{\circ}$ C (by weight). The coating should not be exposed to oil, chemicals or mechanical stress until fully cured.

This product should not be applied on to the surfaces which are known to, or likely to suffer from, rising dampness, potential osmosis problems or have a relative humidity greater than 80% as measured in accordance with BS 8203 Appendix A.

A damp proof membrane is essential to prevent rising moisture as it may cause the concrete to become saturated, and negative pressures to adversely affect the bond with Jotafloor product range.

All cementitious substrates should be at least 28 days old and have a moisture content not exceeding 4%.

Application in external areas & above 40 C consult with Jotun representative for guidance.

Surface (touch) dry: The state of drying when slight pressure with a finger does not leave an imprint or reveal tackiness.

Walk-on-dry: Minimum time before the coating can tolerate normal foot traffic without permanent marks, imprints or other physical damage.

Dry to over coat, minimum: The recommended shortest time before the next coat can be applied.

Dry to over coat, maximum, atmospheric: The longest time allowed before the next coat can be applied.

Dried/cured for service: Minimum time before the coating can be permanently exposed to the intended environment/medium.

Storage
