This is a two component polyamide cured vinyl epoxy based coating. Specially designed as a fast drying, flexible, tie coat between Jotun epoxy primers and antifouling systems. To be used as tie coat / holding primer in immersed environments. It can be applied at sub zero surface temperatures.

Suitable as tie coat for a wide range of Jotun antifouling products.

Dried/cured for service: Minimum time before the coating can be permanently exposed to the intended environment/medium.
